May 5, 2015

Meeting Minutes

1. The Special Meeting of the Town of Islip Industrial Development Agency was called to order on a motion by Councilman Anthony Senft and seconded by Councilman Steve Flotteron. All members were present.

Motions were presented to approve and adopt the following Resolution on the May 5, 2015 IDA Agenda. The resolutions were as follows:

To consider the adoption of a Resolution on behalf of the Town of Islip Industrial Development Agency to approve the minutes from the Special Meeting of the Members of the Town of Islip Industrial Development Agency on April 21, 2015. On a motion by Councilman John Cochrane and seconded by Councilman Anthony Senft, said resolution was approved unanimously.

To consider the adoption of an Inducement Resolution between of the Town of Islip Industrial Development Agency and Northrock Industries, Inc./BAMM, LLC located at 31 Crossways East, Bohemia, New York.
