### A. Corporation Mission Statement

Local Public Authority Name: Town of Economic Development Corporation

**Enabling Legislation**: The Town of Islip Economic Development Corporation was established in 2010 by registering with the New York State Department of State as a not for profit local development corporation. Local development corporations are formed under Not-for-Profit Corporation Law Section 201 as public benefit corporations. LDC's were created to actively promote, encourage, attract and develop job and recreational opportunities for the Not for Profit sector, and to encourage the development of Civic Facilities in the State of NY.

**Mission Statement:** The Mission of the Economic Development Corporation is to promote and foster economic growth, provide employment opportunities and to improve the overall quality of life of the residents of Islip Town.
